You Are The Power through helping serve showing up to city council meetings participating in public events to spread awareness and addressing the harassment head on has enabled Ericka to help those in need with even more public support than before. In 2024 she is finding even more ways to provide aid to those in need.

YATP has sent a team to do a field investigation of our own and has hosted press conferences and rallies to raise awareness of this cause.
